**Subject:** Change of nomination for working group

Grassy Mountain Working Group,

I wanted to inform the working group of some important changes to the Grassy Mountain Project ownership. In May 2019 Hancock Prospecting Pty Ltd (HPPL), an Australian domiciled company, secured control of Riversdale Resources Limited, the 100% owner of the Grassy Mountain Project in a friendly transaction. HPPL is a private company headquartered in Perth, Western Australian and is one of Australia's largest producers of iron ore where the company operates integrated mining, port and rail facilities at the Hope Downs and Roy Hill iron ore operations. HPPL's world-class agribusiness is the country's second largest producer of beef with a total herd capacity size of over 320,000. As a result HPPL has a unique understanding of the environmental and development requirements of Grassy Mountain as well as the importance of agriculture to Alberta.

Representing HPPL at a corporate level will be Dave Davies and Chris Lilley (details appended). At project level there are no changes presently contemplated with respect to the Riversdale permitting and Environmental management team headed by Gary Houston and advised by Martin Ignasiak (Osler Legal) and Mike Bartlett (Millenium EMS).

The Joint Review Panel for the proposed Grassy Mountain Coal Project (the Project) has requested additional information from Benga Mining Limited (the Proponent). Information Request Package 5 can be accessed on the Canadian Environmental Assessment Registry for the Project.

The Joint Review Panel has completed its review of the information submitted by the Proponent and has considered all comments received in response to the public comment period which ended on January 21, 2019.

***Next steps in the environmental assessment***

The Joint Review Panel Agreement outlines the Terms of Reference and the steps for the environmental assessment process, and can be viewed at the following link: <https://www.ceaa-acee.gc.ca/050/evaluations/document/124445?culture=en-CA> (CEAR #80). The Joint Review Panel is currently proceeding with Stage 1 - Review of the Environmental Impact Assessment (EIA) Report and Supplemental Information.

The Joint Review Panel has considered all submissions received during the public comment period held from November 5, 2018 to January 21, 2019 on the sufficiency and technical merit of the EIA and related information from the proponent available on the public registry. The Joint Review Panel's review of information on the record is now complete. The Joint Review Panel has determined that additional information is required to complete the EIA, and in order to meet the requirements outlined in the Joint

Review Panel Agreement for the Project and the Panel's Terms of Reference, before proceeding to a hearing.

The Joint Review Panel has asked the Proponent to provide a timeline for completion of its responses to the information requests. This anticipated timeline will be posted to the Registry once received. The Joint Review Panel will allow for the public review of, and comment on, any additional information it receives from the Proponent in response to the 81 information requests that have been issued in Packages 1-5. The length and timing of the public comment period on the additional information will be determined by the Joint Review Panel at a future date.

Participants are encouraged to check the Registry regularly to review documents related to the environmental assessment of the Project by the Joint Review Panel. La commission d'examen conjoint a considéré toutes les soumissions reçues au cours de la période de consultation publique tenue du 5 novembre 2018 au 21 janvier 2019 au sujet du caractère suffisant et du mérite technique de l'EIE et des renseignements afférents sur le Registre. L'examen par la commission des renseignements inclus au dossier de l'évaluation environnementale est désormais complet. La commission d'examen conjoint a déterminé que des renseignements supplémentaires sont nécessaires pour compléter l'EIE, afin de respecter les exigences de l'entente concernant la constitution de la commission, ainsi qu'à son mandat, avant de procéder à une audience publique.

La commission d'examen conjoint permettra ensuite au public d'examiner et de commenter les renseignements supplémentaires qu'elle recevra du promoteur en réponse aux 81 demandes envoyés en groupe de 1 à 5. La commission établira ultérieurement les dates et la durée de la période de consultation publique sur les renseignements supplémentaires.
