### Summary of Information Available to the Impact Assessment Agency of Canada (the Agency) about:

a) Summary of the information available to the Agency related to the nature and extent of Kasabonika Lake First Nation's Aboriginal and Treaty rights

- Members of Kasabonika Lake First Nation have rights that are recognized and affirmed under section 35 of the *Constitution Act*, 1982.
- Kasabonika Lake First Nation is a signatory to Treaty 9, which provides rights to hunting, trapping and fishing throughout the treaty area.
- Kasabonika Lake First Nation's reserve is about 100 kilometres northwest of the Project's western terminus.
- The Project is partially located within the traditional territory of Kasabonika Lake First Nation.
- Kasabonika Lake First Nation is part of the Shibogama First Nations Council, the Chiefs of Ontario and the Nishnawbe Aski Nation.

b) Summary of the information available to the Agency on the potential impacts to the exercise of Kasabonika Lake First Nation's rights resulting from any change to the environment due to the Project are identified below

**Potential impacts to physical and cultural heritage**

- Potential changes to access, experience or abundance of lands and resources for medicinal, teaching, spiritual, cultural or ceremonial purposes.

**Potential impacts to the current use of lands and resources for traditional purposes**

- Potential changes to access, experience or abundance of lands and resources used for fishing, hunting, trapping, and plant gathering.

**Potential impacts to any structure, site, or thing that is of historical, archeological, paleontological, or architectural significance**

- Potential changes to cultural heritage sites.

c) Summary of the information available to the Agency on any changes to the health, social, or economic conditions of Kasabonika Lake First Nation due to the Project

- Potential changes to physical and/or mental health.
- Potential changes to social conditions or well-being.
- Potential changes to employment, income, and/or economic well-being.
