## **Supplemental Information Request 7**

Socio-economic Effects Follow-up and Monitoring

IR 21.2 – Socio-economic follow-up program

#### Rationale:

Although the EIS recognizes the importance of the socio-economic effects of the Project, plans for monitoring socio-economic effects or ensuring overall socio-economic benefits to the potentially affected communities were not included. SCI was requested to provide a conceptual follow-up and monitoring program, including appropriate indicators, to verify the predictions in the EIS regarding the potential socio-economic effects of the Project.

In its response, SCI states that "the provision of such services and infrastructure falls within the remit of governments..." and as such it is not the responsibility of the proponent to implement such programs.

In Section 2.8.3 the EIS Guidelines state that "the EIS shall outline a follow-up and effects monitoring program, designed to verify the accuracy of the conclusions of the environmental assessment and to determine the effectiveness of the measures implemented to mitigate the adverse environmental effects of the Project. The follow-up and effects monitoring program will also support the implementation of adaptive management measures to address previously unanticipated adverse environmental effects"

The Panel is required to prepare and submit to the federal Minister of the Environment and the provincial Minister of the Environment a report that includes any recommended mitigation measures and follow-up programs on potential changes to the Environment, including socio-economic issues (ToR; Section 3.15). The assessment by the Panel must include a consideration of subsection 6.1(2) of the Ontario *Environmental Assessment Act* and section 19 of the *Canadian Environmental Assessment Act*, 2012. This includes the requirements of any follow-up programs in respect of the Project (ToR; Section 2.2(xi)).

Further information on the follow-up and monitoring of socio-economic effects is needed.

### **Information Request:**

Provide information on the design of a conceptual monitoring and follow-up program that will allow SCI to assess the actual socio-economic effects against the predictions, as well

as to measure the effectiveness of proposed mitigation measures. The program should include key performance indicators and a monitoring strategy.

#### **SCI Response:**

Following as requested is information on the design of a conceptual monitoring program. This conceptual program has been reviewed with both the Town of Marathon and Pic River First Nation (PRFN). Further consultation with both is anticipated as the conceptual program details are finalized and implemented. It is anticipated that this monitoring program will be a core element of project implementation committees with both the Town and PRFN.

The socio-economic effects monitoring and follow-up program concept will see SCI collaborate in the collection and review of relevant indicators with relevant departments and agencies responsible for the management of social and economic programs.

Monitoring will commence at the start of Project activity and continue for the life of Project, but draw on pre-Project baseline data. The frequency of monitoring will be established in consultation with the relevant departments/agencies, but is anticipated to be more frequent during the construction phase than the operations phase. The geographic area(s) that will be monitored will be specific to each topic, and will again be established in consultation with the relevant departments/agencies, so as to ensure consistency with their data collection areas. The geographic areas monitored will have regard to the locations where SCI project employees are located. At this point it is anticipated that the socio-economic monitoring program will include the Town of Marathon, Terrace Bay, Manitouwadge, Pic River First Nation as the most proximate First Nation community and other First Nation communities as appropriate and determined in consultation with those communities. Any Metis people who live in local communities such as Marathon should be captured by consultation with local agencies, although the Red Sky Métis Independent Nation and the MNO will also be consulted, in particular on demographic information.

Pic River as the most proximate First Nation community has indicated that it will participate in the design and collection of information, and participate in the interpretation of the results from the monitoring program. These results will be shared through community meetings and routine information sharing protocols.

The indicators used will similarly be established in collaboration with the relevant departments/agencies so as to ensure the information is of greatest use in the understanding and management of effects, including consistency with the existing monitoring and management measures of the agencies/departments. This will also permit the development of time series covering the pre- and post-Project commencement periods, and thus a measure of change from the baseline conditions.

The monitoring data so gathered will be assessed in conjunction with SCI-provided information about direct Project effects as appropriate, thereby establishing the Project's direct contribution to overall change.
